## ACTIVE TRANSPORTATION INFRASTRUCTURE INVESTMENT PROGRAM

Next opportunity anticipated Summer 2025.

ADMINISTERED BY: FEDERAL HIGHWAY ADMINISTRATION (FHWA)

The FY 2023 Active Transportation Infrastructure Investment Program (ATIIP), administered by the FHWA, aims to distribute up to \$44,550,000 to enhance the safety and connectivity of active transportation networks or spines. Eligible projects will foster construction of facilities promoting human-powered mobility, integrating with transit services, and connecting destinations within communities or across regions.



### ELIGIBLE APPLICANTS

Class I railroads are not eligible applicants under the ATIIP; however, they may partner with eligible applicants – as Project Partners – to pursue funding for projects.

- Local or regional governmental organization, including a metropolitan planning organization (MPO) or regional planning organization or council
- Multicounty special district
- State
- Multistate group of governments
- Indian Tribe

### DEFINITIONS

**Active Transportation Networks:** Facilities like sidewalks, bikeways, and trails connecting destinations within a community to metropolitan area, such as schools, workplaces, and recreational areas.

**Active Transportation Spines:** These facilities connect communities, metropolitan areas, or even states, including rail trails, walking paths, or bike routes, serving as primary routes through regions.


**Active Transportation:** Mobility options primarily powered by human energy, like walking and bicycling, which may also include activities like scooting or skating, but excluding electric micromobility options not primarily human powered.

## ATIIP Planning and Design

### Up to \$19,620,000

Funds for planning projects can be used to develop a plan for an active transportation network or spine project, or to update and further develop their plan

- Public engagement activities including outreach to disadvantaged communities, strategies for public input, etc.
- Design and planning studies that will support the development of construction projects, including traffic studies, active transportation network plans, connectivity analyses, asset inventories, and data collection
- Conceptual and preliminary engineering.

## ATIIP Construction

### Up to \$41,550,000

Construction grants may be utilized to fund various project components, as well as fees associated with project execution and financing

- Property acquisition, site preparation, and construction costs
- Bonds, permits, insurance, and contractor fees
- Training and education initiatives focused on the safety of project users

## Questions to ask yourself about the project:

### Can applicants apply to multiple grants?

Yes, applicants may apply for more than one grant; however, the application must be for separate projects.

### Are pre-award costs eligible?

No, any costs incurred prior to FHWA's obligation of funds for projects are ineligible for reimbursement or to count as cost-share (unless authorized in writing by FHWA after announcement).

### What is the Project Cost Share?

It is a 20% funding match for all project types. For projects serving communities with a poverty rate of over 40%, based on the majority of census tracts served by the project, the federal share is 100% of the total project cost.
